THESE ORGANIZATIONS PROVIDE CULTURE AND ENTERTAINMENT OPPORTUNITIES TO EDUCATE AND A LOCATION TO EXPAND THEIR MISSION. ORGANIZATIONS THAT DON'T HAVE A PHYSICAL SPACE OR A LARGE-ENOUGH SPACE CAN MAKE USE OF THE THEATRE. THE LOCATION OF THE THEATRE IS IN THE HISTORIC MARINES' MEMORIAL CLUB, WHICH MAKES IT THE IDEAL VENUE FOR EVENTS SERVING AND HONORING VETERANS AND CURRENTLY-SERVING MEMBERS OF THE ARMED FORCES AND THEIR FAMILIES. AN EXAMPLE IS THE ANNUAL MEMORIAL SERVICE IN WHICH WE HONOR AND PAY TRIBUTE TO THE GOLD STAR PARENTS WHOSE SONS AND DAUGHTERS LOST THEIR LIVES IN THE SERVICE OF OUR COUNTRY. THEY ARE ACNOWLEDGED AND HONORED IN A MOVING CEREMONY IN THE THEATRE. THEY ARE ALSO OFFERED GRIEF

THE FOUNDATION'S MISSION MIRRORS THE ASSOCIATION'S MISSION IN THAT IT HONORS THE LEGACY OF MILITARY SERVICE AND PROVIDES CHARITABLE, ART, AND EDUCATIONAL RESOURCES FOR SAN FRANCISCO AND SURROUNDING COMMUNITIES. ACCORDINGLY, THIS PARTICULAR FORM 990 REPORT CONTAINS ONLY THE FINANCIALS FROM THE THEATRE OPERATION AND DOES NOT INCLUDE ANY FOUNDATION EFFORTS DUE TO THE FACT THAT IT WAS NOT ACTIVE MOST OF THE FISCAL YEAR.
